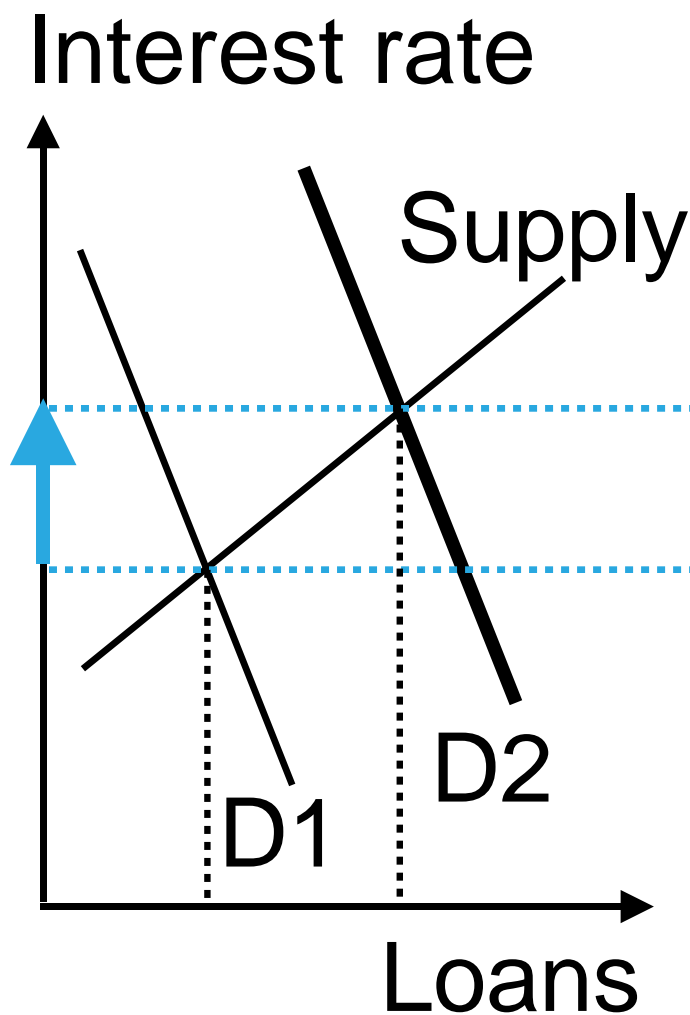


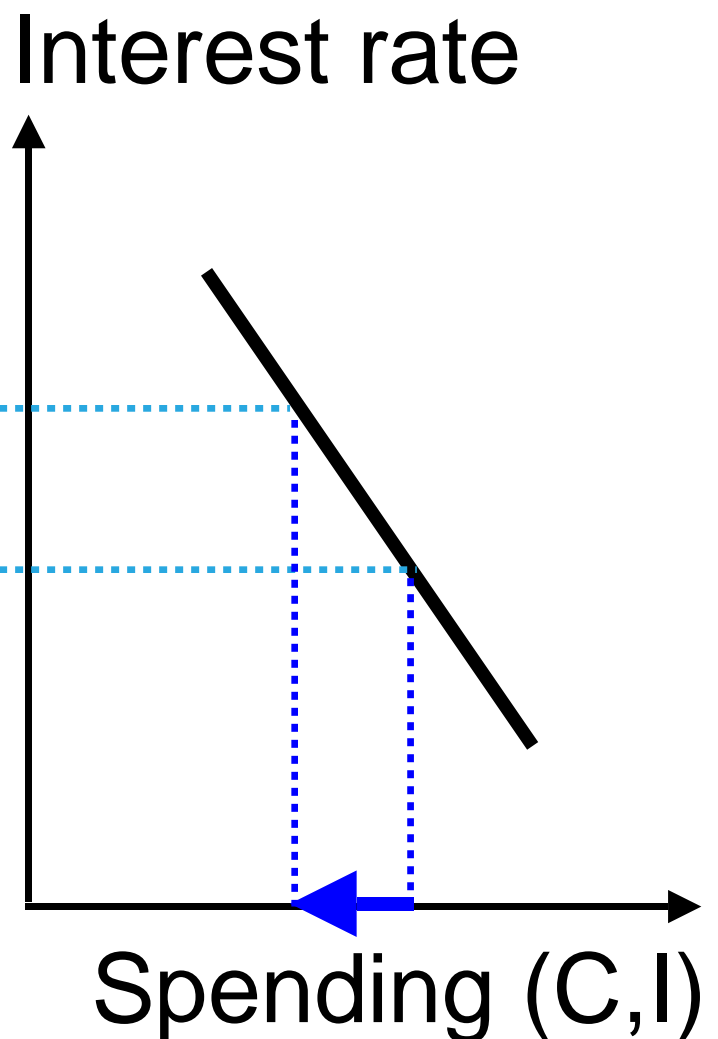
# Crowding-out effect
