

# Profit and loss (rules)

① **Marginal condition:**

$$MC = MR$$

+

② **Average condition:**

• **Maximum profit:**  $AC < AR$

• **Minimum loss:**  $AC > AR$

• **Normal profit:**  $AC = AR$
